KEYNOTE SPEAKERS (alphabetical order)



Elliott Abrams

Senior Fellow for Middle Eastern Studies at the Council on Foreign Relations in Washington, D.C.

Elliott Abrams is a diplomat, lawyer and political scientist who served as deputy assistant to the president and deputy national security advisor in the administration of President George W. Bush, supervising Middle East policy. Prior to that, Mr. Abrams served in the administration of President Ronald Reagan, and on the staffs of Senators Henry M. Jackson and Daniel P. Moynihan. He is senior fellow at the Council on Foreign Relations and holds degrees from the Harvard College, the London School of Economics, and Harvard Law School. He served as the chairman and a member of the United States Commission on International Religious Freedom.



Prof. Uzi Arad

Chair, Technion's Grand Strategy Forum; Senior Visiting Fellow, INSS; former National Security Advisor to the Prime Minister and Head of Israel's National Security Council (NSC)

Prof. Uzi Arad served as national security and foreign policy advisor to Israel's Prime Minister Netanyahu, as well as the Head of the National Security Council (2009-2011). Prof. Arad has been on the faculty of IDC, where he founded and directed the Institute for Policy and Strategy, and established the "Annual Herzliya Conference Series". Prior to that, Prof. Arad held number of positions with Mossad, including as Director of Intelligence Division, as well as at the Hudson Institute and Tel-Aviv University. He has a PhD in international relations from Princeton University, and was awarded the rank of Officer of the Legion of Honor by France.





Prof. Irwin CotlerFormer Minister of Justice and Attorney General of Canada;
Member of Parliament; Emeritus Professor of Law at McGill University

Prof. Cotler intervened in landmark Charter of Rights cases in the areas of free speech, freedom of religion, minority rights, peace law and war crimes justice. Prof. Cotler initiated the first-ever comprehensive reform of the Supreme Court appointment process and helped make it the most gender-representative Supreme Court in the world. He is Chair of the Inter-Parliamentary Group for Human Rights in Iran; Inter-Parliamentary Group of Justice for Sergei Magnitsky; and All-Party Save Darfur Parliamentary Coalition. Prof. Cotler has served as Counsel to prisoners of conscience including Andrei Sakharov & Nathan, Nelson Mandela, Jacobo Timmerman, Prof Saad Eddin Ibrahim. He is the recipient of eleven honorary doctorates, and numerous awards.



Minister Jean-Yves Le DrianMinister of Europe and Foreign Affairs of France (TBC)

Jean-Yves le Drian is Minister for Europe and Foreign Affairs since 2017. He began his political career by being elected Municipal Councillor of Lorient in 1977, then National Assembly deputy in 1978. He later became mayor of Lorient in 1981. In 1991, he entered the government and became Minister of State for Marine Affairs. In 1998, he was elected Brittany Regional Councilor, and became President of the Regional Council in 2004. Between 2012 and 2017, under the five-year term of François Hollande, Jean-Yves le Drian was Minister of Defense. Since 1973, he has been academic, and since 1993 he has been Honorary National Education Inspector-General. He holds a PhD in History.





Gen. Amos Gilead

Executive Director, Institute for Policy and Strategy (IPS) and Chair, Annual Herzliya Conference Series, IDC Herzliya; former Director of Policy and Political-Military Affairs, Ministry of Defense of Israel

Prior to assuming his current position as the Executive Director of the Institute for Policy and Strategy (IPS) at IDC Herzliya in 2017, Gen. Gilead led a distinguished career for more than three decades in the IDF and in the Defense Establishment, his last position being Director of Policy and Political-Military Affairs at the Ministry of Defense. In this position, Gen. Gilead managed Israel's international strategic and political-military relations and played a key role in developing Israel's defense relations with key Sunni-Arab nations. Beforehand, he served in critical positions such as Chief of the Intelligence Research and Analysis Division, IDF Spokesperson, Coordinator of Government Activities in the Territories and Military Secretary of Prime Minister and Defense Minister Yitzhak Rabin.



Minister Ayoob Kara

Minister of Communications of Israel

As Minister of Communications and Minister in the Prime Minister's Office since 2017, Minister Kara often serves the Prime Minister by leading high-level missions dealing with international affairs. MK Kara led the regional integration initiative resulting in expanding economic cooperation with Jordan, including the "Jordanian Gateway", an industrial zone located in Jordan and benefitting both Jordan and the Palestinian Authority. Within this capacity, Minister Kara succeeded in advancing the Dead Sea – Red Sea project. Minister Kara served as a Member of Knesset for the Likud Party in the 15th, 16th, 18th and 20th Knesset. He served on many Knesset Committees and as Deputy Speaker of the Knesset. He was also a member of the Knesset Christian Allies Caucus, and the Lobby for the Prevention of Illegal Immigration to Israel. In the 20th Knesset, Minister Kara was appointed Deputy Minister for Regional Cooperation. He was discharged from the IDF with the rank of Major, holds a Bachelor of Law degree from Ono Academic College, and an MA in Public Policy from Tel-Aviv University. He is a lawyer by profession and a frequent lecturer.





Minister Bruno Le Maire

Minister of the Economy and Finance of France (TBC)

Bruno Le Maire currently holds the position of Minister for the Economy and Finance. Bruno Le Maire began his career as Foreign Affairs Adviser at the Ministry of Foreign Affairs. In 2002, he became Strategic Affairs Adviser to the Minister of Foreign Affairs and then was appointed Adviser to the Minister of the Interior in 2004. In 2005, he joined the Prime Minister's office, first as an adviser and then as the Chief of Staff from 2006 to 2007. In June 2007, he was elected MP of the Eure and re-elected since then. In December 2008, he was appointed Minister of State for European Affairs before being appointed Minister of Agriculture and Fisheries in June 2009. He gratuated from École normale supérieure, Sciences Po Paris and École nationale d'administration (ENA). He holds a PhD in French language and literature.



MEP Fulvio Martusciello

Chair of the Delegation for Relations with Israel, European Parliament

Mr. Fulvio Martusciello is a Member of the European Parliament. He was Assistant at the Bank of Italy in the sector of public services. In 2014 he was elected Member of the European Parliament in the Southern Italy constituency. He is a member of the Group of the European People's Party, Chair of the Delegation for Relation with Israel and a member of the Conference of Delegation Chairs. He is a member of the Committee on Budgetary Control and of the Committee on Economic and Monetary affairs, and also a member of the Delegation to the Parliamentary Assembly of the Union for the Mediterranean. In Italy, he was elected member of the Campania Regional Council for the first time in 1995. Mr. Fulvio Martusciello studied Law at the University of Naples "Federico II".





Dan MeridorFormer Deputy Prime Minister and Minister of Intelligence and Atomic Energy of Israel

Dan Meridor is Chairman of the Board of Governors at Bezalel Academy of Arts and Design. Previously, he was Deputy Prime Minister and Minister of Intelligence and Atomic Energy of Israel until March 2013. From 2003- 2008, Dan Meridor practiced law at Haim Zadok & Co Law Offices. During this period, he also served as chairman of The Jerusalem Foundation. He previously served as Minister without portfolio in the Israeli government, Chairman of the Foreign Affairs and Defense Committee of the Knesset, Minister of Finance of Israel, and Minister of Justice. Mr. Meridor also served as Secretary of the Cabinet under Prime Ministers Menahem Begin and Yitzhak Shamir.



Pierre RehovFilmmaker, journalist and novelist

Pierre Rehov is the pseudonym of a French-Israeli filmmaker, journalist and novelist. Born in Algeria in1952, he moved to France in 1961, studied law in the French Universtity Assas, and later counter-terrorism at IDC, Universtity of Hertzlyia. Since the uprising of the second Intifada, he has been working as an independent producer and director, and took many risks to expose the propaganda machine behind the fake news tthat defame Israel. In 2008, he was the only French journalist embedded in Iraq in the US army. In 18 years, he has produced and directed 14 documentaries about the Middle East conflict. He also writes regularly in the French Newspaper Le Figaro, for the Gatestone Institute and sometimes in the Jerusalem Post. As a writer, he wrote two novels under this pseudonym, and 5 under other names, all published by major French publishing companies.

Jacques AudibertFormer Diplomatic Advisor to the French President (TBC)

Jacques Audibert is a graduate of the Strasbourg School of Journalism and a former ENA student. He was the advisor to Roger Fauroux, the Minister of Industry and Regional Development in 1988. He has served as a diplomat in Germany, Vietnam, Quebec and the United Kingdom. He was the Director General of Political Affairs and Security at the French Ministry of Foreign Affairs from 1998 to 2014, then Diplomatic Advisor and G7-G20 Sherpa of the French President from 2014 to 2017. He joined SUEZ Group as the Deputy General Secretary in 2017.



Pavel Baev

Associate Research Fellow, Russia/NIS Center, French Institute for International Relations (IFRI)

Dr. Pavel K. Baev is a Research Professor at the Peace Research Institute, Oslo (PRIO); he is also a Senior Non-Resident Fellow at the Center for the United States and Europe (CUSE) at the Brookings Institutions, Washington DC; a Senior Associate Researcher at the Institut Français des Relations Internationales (IFRI), Paris; and a Senior Associate Research Fellow at the Italian Institute for International Political Studies (ISPI, Milan). After graduating from the Moscow State University (MA in Political Geograph), he worked in a research institute in the USSR Defence Ministry, received PhD in International Relations from the USA & Canada Institute, USSR Academy of Sciences, and then worked in the Institute of Europe, Moscow, before joining PRIO in October 1992. His research on Russia's policy in the Middle East is supported by the Norwegian Foreign Ministry; other research interests include the transformation of the Russian military; the energy and security dimensions of the Russian-European relations; Russia's Arctic policy; Russia-China partnership; and post-Soviet conflict management in the Caucasus and the greater Caspian area. His weekly column appears in Eurasia Daily Monitor.





Dr. Małgorzata Bonikowska

President, Centre for International Relations (CIR)

Dr. Bonikowska is a political scientist and EU expert, media commentator in international affairs, President of the Centre for International Relations, a leading Polish independent think tank in foreign affairs. She is the co-founder of the THINKTANK Centre, publisher of "THINKTANK" journal. Dr. Bonikowska worked as editor in current affairs department of the Polish Public Television, as Head of the European Information Centre and was Adviser to the Minister at the Ministry of European Integration, for the European Commission as expert and Director of the EU Information and Communication Program, and was senior advisor at the Centre for Human Resources Development under the Ministry of Labor and Social Policy. She was also consultant and advisor to the sever Ministers (Ministry of Foreign Affairs, Ministry of Economy, Ministry of Regional Development, Ministry of Education and Ministry of Health). She graduated from Warsaw University, University of Sorbonne in Paris, completed doctoral programs in the Polish Academy of Sciences, and in the San Marino Republic. She was a scholar at Political Sciences and Public Affairs Dept of Columbia University New York (the Fulbright Program).





Jérôme Bonnafont

Director of the Middle East and North Africa Directorate, Ministry of Europe and Foreign Affairs of France

Mr. Jérôme Bonnafont graduated from the Paris Institute of Political Studies (Sciences Po) and is a former student of the French National School of Public Administration (ENA). Mr. Bonnafont has served in various services of the French Republic and of the Ministry covering Europe, South Asia, the Middle East and the United Nations. He served as the Embassy Secretary at the French Embassy in India, the Special Assistant at the Economic and Financial Affairs Directorate of the French Ministry of Foreign Affairs, Counsellor at the French Embassy in Kuwait from and at the Permanent Mission of France to the United Nations. He served as Special Assistant to the Legal Affairs Department of the French Ministry of the Environment, and was assigned to the Presidency of the French Republic, as technical Adviser in the Diplomatic, and then as Spokesperson. He was French Ambassador Extraordinary and Plenipotentiary to India and Spain, and served as Director of the Minister's Private Office at the Foreign Affairs Ministry. Mr. Bonnafont is Chevalier in the Legion of Honour.



Patrick Calvar

Former Director General of the French Security Service, the General Directorate for Internal Security (DGSI)

Patrick Calvar has spent over 30 years in the French security and intelligence services, starting his career during the Cold War. He joined the Police in 1977 and Security Service in 1984. He has worked at all levels of responsibility and was eventually appointed Deputy Director of the security service. In 2010, he became director of intelligence of the foreign intelligence service, the General Directorate for external security (DGSE). In 2012, he was appointed as Director General of the French security service, the General Directorate for Internal Security (DGSI). He retired from Government Service in May 2017. He was awarded Officier de l'ordre national du Mérite and Officier de l'ordre National de la Légion d'Honneur. Currently he is the head of C. Conseil, a strategic intelligence consulting company. He also teaches at Sciences Po Paris School, is Special Advisor at Montaigne Institute, and Europe and senior associate fellow at the Royal United Services Institute (RUSI).





MP Elise Fajgeles

Chair of the Parliamentary Friendship group France-Israel (TBC)

Mrs. Elise Fajgeles is a Member of Parliament of Paris (3rd and 10th arrondissements) since July 2017. Member of the Committee on Laws, she works particularly on topics related to immigration and integration - she is rapporteur of the law for a controlled immigration, an effective right of asylum and a successful integration -, secularism and the fight against terrorism. She is also president of the France-Israel friendship group in the National Assembly. Deputy mayor of the 10th arrondissement in charge of transport, public space and cleanliness since 2008, she resigned from her mandate to be in compliance with the law on the non-cumulation of parliamentary mandates. After being a lawyer from 1997 to 1999, she created a theater company and became advisor in charge of human resources and legal affairs in the Ministry of Culture from 2006 to 2016.



Zacharie Gross

Director, Nuclear and Missile Non-Proliferation and Disarmament, Ministry of Europe and Foreign Affairs of France

Zacharie Gross is a career diplomat with a particular interest in security, nonproliferation, disarmament and energy issues. He took up his current position as Head of nuclear non-proliferation and disarmament (ASD/QA) at the French Foreign Ministry in 2015. His unit covers issues ranging from nuclear nonproliferation, including Iran/nuclear and DPRK, and nuclear disarmament including NPT, CTBT-, to nuclear deterrence, space security policy, NSG and missiles export controls regimes, and missile defense. Prior to this, Zacharie Gross served as Head of the Situation Center at the French Foreign Ministry, and as Deputy Chief of Mission at the French Embassy in Tel Aviv, Israel. Before joining the Foreign Ministry, Zacharie worked in Moscow as a Junior officer in an EU Technical assistance programme (TACIS) and helped open the first foreign Master's course at the Moscow institute of international relations (MGIMO). Zacharie Gross studied at Institut d'Etudes Politiques de Paris (Bachelor's degree), University of Sussex at Brighton (MA) and Université Paris-Dauphine (Master's) as well at the Areva University (Aix en Provence) and the French Foreign Ministry's Institut diplomatique et consulaire.





David Hatchwell Altaras

Co-Founder, ACOM

David Hatchwell Altaras holds an MBA in International Business and Finance from New York University's Stern School of Business and is a graduate of the School of Foreign Service at Georgetown University in Washington DC. He is the President of EXCEM Group, an investment and consultancy group of companies, headquartered in Spain and active internationally. Mr. Hatchwell worked in the Corporate Finance department at Goldman Sachs as well as in the Treasury Department at the Republic National Bank of New York, now HSBC. From 1992 to 2000 he lived in Beijing and developed EXCEM Grupo's operations in China. In 2003 he was responsible for bringing Real Madrid to China at a very critical moment, post SARS through buying the club's Asian rights. That year he was named Honorary Citizen of the city of Kunming (Yunnan Province). He has been a founding member of the Executive Committee of the Spain-China Foundation since 2004. Mr. Hatchwell has been a founding member of the Spain-Israel Chamber of Commerce since 2006. Mr. Hatchwell was President of the Jewish Community of Madrid, Spain for 6 years and was previously vice president for 3 years.



Alexandra de Hoop Scheffer

Director of the German Marshall Fund (GMF) Paris Office

Dr. Alexandra de Hoop Scheffer is an accomplished expert on US and French foreign policies, transatlantic relations and international security, she has held several positions in the French government and academia and advised international organizations. At GMF, she leads the Transatlantic Security Program, and the Strategy Group on the Future of US Global Leadership. Dr. de Hoop Scheffer served as special advisor for US foreign policy and transatlantic relations on the Policy Planning Staff of the French Ministry of Foreign Affairs and as associate professor at Sciences Po Paris. She has contributed to several high-level working groups on post-conflict reconstruction for the United Nations, French Ministry of Defense and NATO. She holds a Ph.D. in political science (Sciences Po Paris), two MA degrees in conflict and security studies and political science (Sciences Po Paris) and a BA in War Studies (King's College London). She is the author of the book *Hamlet en Irak* (2007) and co-director of the Parisbased journal Politique Américaine.





Iwona Janicka

Vice-President, Board of Polish-Israeli Chamber of Commerce

Iwona Janicka is co-Founder and serves as a Vice President of the Polish

– Israeli Chamber of Commerce. The organization aims to bridge business between Poland and Israel, eliminate financial, cultural and beaurocratic barriers between the two countries, stimulate an environment supporting economic growth. She is also the CEO of Rechters, a public relations firm headquartered in Warsaw. Rechters' expertise is in integrated brand communication, public affairs and digital and social media. Ms. Janicka who graduated from the University of Wroclaw dept. Politics and International Affairs, has 20 years of public relations work experience. Following several years of work as a journalist, during the years 2006 - 2012 she was the head of the Warsaw office of Cohn and Wolf, an American public relations firm which is a subsidiary of the global conglomerate WPP. In this capacity she worked for institutions and brands such as Dell, Coca-Cola, Procter&Gable, Sony Entertaiment, Medtronic, Micheline, GSK, Microsoft.



Col. Richard Kemp CBEFormer Commander of the British Armed Forces in Iraq and Afghanistan

Richard Kemp was a British Army officer who served from 1977-2006, including on operations in Northern Ireland, Afghanistan, the Balkans, Iraq and elsewhere in the Middle East. He headed the international terrorism team for the British Government's Joint Intelligence Committee and was Chairman of the COBRA Intelligence Committee. He is a Senior Associate Fellow of the Royal United Services Institute, a Fellow of the Jerusalem Center for Public Affairs, a patron of the Campaign Against Anti-Semitism and a board member of the Friends of Israel Initiative. He has visited the Gaza combat zone during several recent conflicts between Hamas and Israel and has testified at emergency sessions of the UN Human Rights Council in Geneva, at the Israeli Knesset and the US Congress on the conflicts. He is an author, a columnist for the London Times, the Telegraph and other national and international newspapers and a regular commentator in the British and international media on security, defence, counter terrorism and intelligence. Colonel Kemp is also a patron and advisory board member of the Pinsker Centre, a UK-based organisation which combats antisemitism and the campus BDS movement.





Patrick KlugmanDeputy Mayor of Paris for International Relations and the French Speaking World

Patrick Klugman is a lawyer by training and profession, and committed to the defense of Human Rights and fundamental freedoms in France and abroad. He has often campaigned against racism in France. He was elected Councilor of Paris in March 2008, and Vice-Chairman of the Socialist group in the city council of Paris. With great support of Anne Hidalgo during the 2014 municipal elections, Mr. Klugman was appointed deputy Mayor of Paris in charge of International Relations and Francophone countries. During COP21, he was in charge of the Climate summit for local leaders, which gathered around 800 Mayors at Paris City Hall. In 2014, he was elected PLATFORMA spokesperson, an organization representing the voice of European local and regional authorities. He also serves on the Board of the C40, a network representing the 96 major cities of the world and accounting for 25% of the total world GDP and 650 million of people. In 2017, he was appointed "Knight of the French National Order of Merit".



Frédéric Lefebvre

Former Member of the French National Assembly and Secretary of State for Commerce, Small and Mid-sized Businesses, Tourism, Independent Professions and Consumer Affairs of France

Frédéric Lefebvre is a French politician, businessman and lawyer. He was deputy mayor of Garches from 1989 to 2007. From 1993 to 2007, he served as parliamentary assistant, advisor, deputy chief of staff, director of cabinet for Nicolas Sarkozy. In 2004, he was elected to the Île-de-France Regional Council. He became MP in July 2007 and served as spokesman of the conservative party. In 2010, he was appointed Secretary of State in charge of Trade, Small and Medium Enterprises, Tourism, Services, Liberal Professions and Consumption. From 2013 to 2017, he was MP for the French people established in North America. In June 2017 he left the conservative party and founded a new rightwing political party named *Agir*. He published 5 books. Lawyer registered at the Paris Bar, he is a partner at L & L partners in Atlanta, since June 2018.





Carsten OvensMember, Hamburg State Parliament (CDU)

With more than a decade of experience in politics, Carsten Ovens is the CDU spokesperson for science and digital business affairs with a strong focus on startup initiatives. Recently he initiated the "Friends of Israel within the Union" circle, a network of more than fifty members of State Parliaments and the German Bundestag from CDU & CSU. After several years of working in business development, marketing and management consulting, Carsten has returned to academia, researching social media marketing and communication effects at the University of Hamburg. He also consults firms in optimizing their business strategy to meet market needs. In 2016 he was appointed as an ambassador of the German-Israeli-Startup-Exchange program. Dr. Jean-Loup Samaan

Associate Professor in Strategic Studies, Near East South Asia Center

Jean-Loup Samaan is an associate professor in strategic studies with the Near East South Asia Center. His research focuses on Middle Eastern strategic affairs, in particular the evolution of the Gulf security system, and the Israel-Hezbollah conflict. Prior to his position in the UAE, he was a researcher for the Middle East Faculty at the NATO Defense College in Rome, Italy between 2011 and 2016. He was a policy advisor at the French Ministry of Defense from 2008 to 2011. Dr. Samaan has authored four books and several articles for various international academic and policy journals such as the RUSI Journal, Survival, Orbis, Comparative Strategy, Politique Etrangère, and Internationale Politik.





Laurent SorbierAdvisor to the CEO, Group Onepoint

Laurent Sorbier is adviser to the president of One point and President of the professionalisation and solidarity Fund for artists and entertainment technicians. Until May 2016, he was a member of the regulatory authority for online gambling. In charge of information technology for François Fillon (1995-1997), Minister in charge of telecommunications, then advisor for the information society at the Commissariat Général du Plan, he headed Spray, an Internet Service Provider and Portal, before becoming general director of eAuctionRoom, a company specialized in Internet retransmission of auctions. Technical advisor for information technology and telecommunications to the Prime Minister, Jean-Pierre Raffarin, he was then appointed Referendum Advisor to the Court of Auditors. He joined the company mySkreen (portal of legal audiovisual offer on the Internet, participation of the groups Dassault and Le Figaro) as General Director, before being appointed in 2012 Director General of the public establishment Picasso - Paris National Museum, until 2013. Laurent Sorbier is a graduate of the Ecole Normale Supérieure of Fontenay-Saint-Cloud, graduate from Sciences Po Paris and holds a master's degree in Philosophy and a high degree in Public Law (University Paris I). Laurent Sorbier is a knight in the National Order of Merit, knight in the Order of Arts and Letters and holder of the gold medal of Youth and Sports.



James Sorene
Chief Executive Officer, Britain Israel Communications & Research
Centre (BICOM)

Before becoming CEO of BICOM, a British think tank that focuses on Israel, the Middle East and Britain-Israel relations, James Sorene was a Senior Civil Servant for the UK Government and Head of Communications and Official Spokesman for Deputy Prime Minister Nick Clegg. Mr. Sorene held senior positions in communications at the Department of Health and the Home Office where he worked on counterterrorism. He holds a Law degree from Queen Mary at the University of London and an MA degree in Middle Eastern Studies from the School of Oriental and African Studies. He writes regularly about Israel and Middle East issues and appears frequently on UK TV and radio programmes. In 2017, BICOM published a paper, based on an Israeli-Palestinian track two dialogue co-hosted with Chatham House that critiqued new ideas to solve the Israeli-Palestinian conflict.





Dr. Bruno TertraisDeputy Director, Foundation for Strategic Research (FRS)

Bruno Tertrais is Deputy Director of the Fondation pour la Recherche Stratégique (Foundation for Strategic Research, FRS), the main French think-tank on international security issues. His areas of expertise include geopolitics and international relations, strategic and military affairs, nuclear deterrence and nonproliferation, US policy and transatlantic relations, security in the Middle East and in Asia. He was previously a Senior Research Fellow at FRS, a Special Assistant to the Director of Strategic Affairs at the Ministry of Defense, and a Director of the Civilian Affairs Committee at the NATO Parliamentary Assembly. He was a Visiting at the RAND Corporation, and a member of the Commission on the White Paper on Defense and National Security appointed by President Sarkozy and of the Commission on Foreign and European Policy appointed by Minister Alain Juppé.
